Community Engagement: A signature program of the San Diego River Park Foundation is to engage people in creating a better future for the San Diego River. This program brings together dozens of organizations and public agencies to host the annual San Diego River Days as well as other events. In addition, the program helps to manage four public park areas and works in other areas to organize volunteer and other activities.

4b (Code:) (Expenses \$ 130,902 including grants of \$) (Revenue \$)

Watershed Stewardship: This program includes our efforts to restore and care for portions of the upper reaches of the San Diego River, considered a globally significant ecosystem with perhaps the most biodiversity of any place in the continental United States and elsewhere. This program also works to manage critical pieces of the watershed to advance biological integrity while providing outdoor recreation, public government, and scenic preservation.

San Diego River Park Trail System: This program works to advance the establishment of a 52 mile long park and trail system along the river. The San Diego River Foundation is recognized as the leading non-profit champion of this vision as it led the effort to create a conceptual plan for this project. The San Diego River Park Foundation is working to complete sections of the trail, advocate for parks to be included in development projects and its own projects.

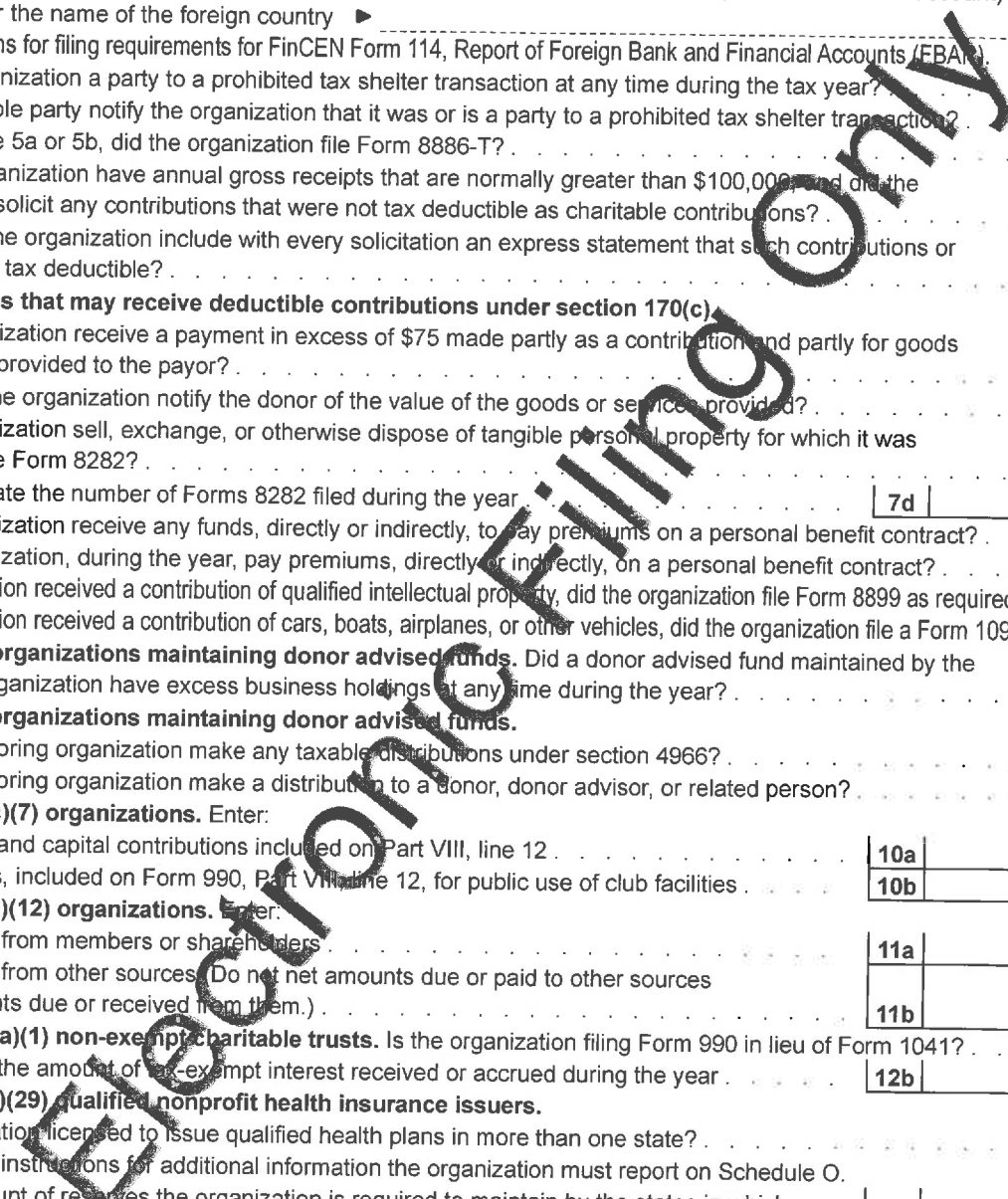

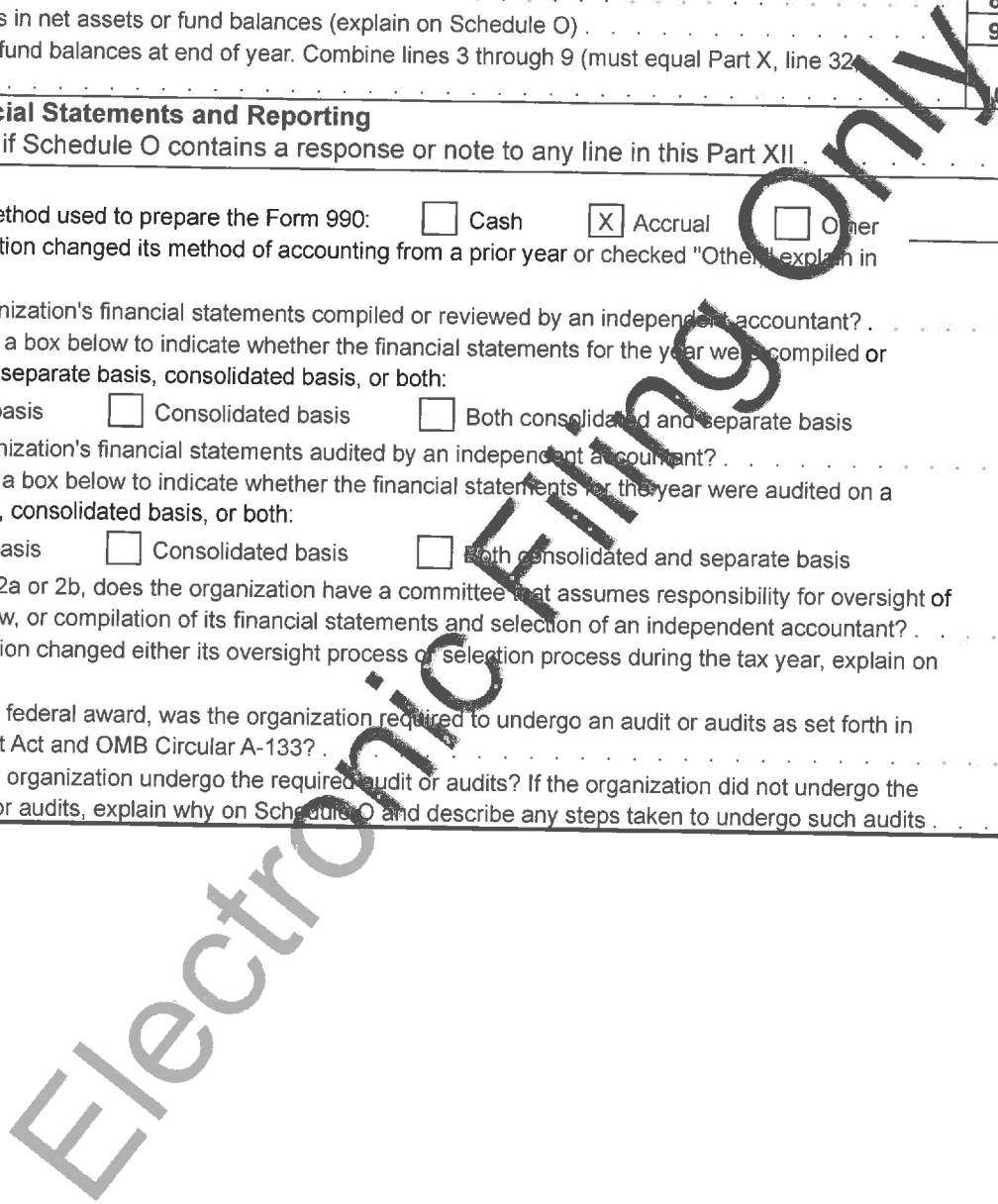
